

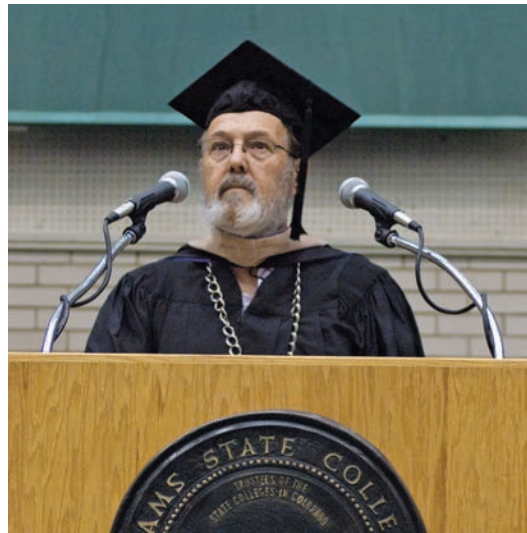

ACCOUNTING ALUMNI HONOR IMPACT OF GERALD CORNING

Having achieved success in his profession, James "Jamie" Harvey '83 established the Gerald Corning Endowment in honor of his Adams State University mentor and emeritus professor of accounting. The Gerald Corning Endowment will be awarded to a student who is eligible to sit for the CPA exam.

Corning retired from the School of Business in 2010, after teaching accounting courses for 35 years. "I am a little overwhelmed by this honor. I tried to provide my students with the skills they needed to succeed and to push themselves as much as they could," said Corning, who relates to the pressure his students experience when

preparing for the exam. "I went through it myself. A little help makes a lot of difference."

Now in his fifteenth year as the Chief Financial Officer for USA Swimming in Colorado Springs, Harvey remembers Corning being available after class and willing to provide extra help and offer great advice when preparing students for the CPA exam. "He was confident in your abilities, even if you had doubts."

One contributor to the scholarship is Karla Willschau '84, managing partner for the Alamosa Certified Public Accounting firm Wall, Smith, Bateman, Inc. She agreed, "Mr. Corning was always interested in what I was doing, whether it was school or work related. He was committed to preparing students to take the CPA exam, and because of that, Adams State experienced a high pass rate. He kept up with how his students did on the exam." She added, "My education at Adams State made a huge impact on my professional life. Working in the San Luis Valley, I see Adams State graduates working in various businesses every day, and the level of sophistication is high because of Adams State."

Both Harvey and Willschau encourage current and future accounting students to study hard and keep to a higher standard. Harvey noted, "My degree was a critical prerequisite for entry into the accounting profession. A liberal arts education prepares a person to thrive and contribute in a complex and diverse world."

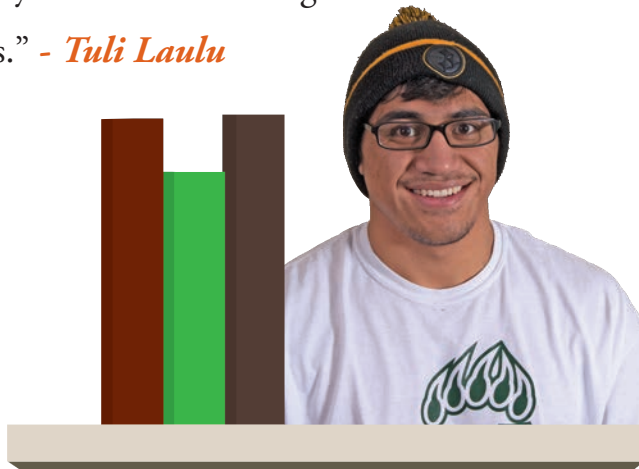
